Consequent to repeal of the Jammu and Kashmir Right to Information Act, 2009 and application of the Right to Information Act, 2005 (Central Act) to the Union territory of Jammu and Kashmir by Jammu and Kashmir Reorganization Act, 2019, all the Public Authorities are mandated to appoint Public Information Officers and First Appellate Authorities in terms of the Central Act.

Accordingly, all the Public Authorities in the Union territory of Jammu and Kashmir shall appoint Public Information Officers and First Appellate Authorities in all administrative units/offices, in terms of Right to Information Act, 2005.
