The experience Certificates should be supported by the Bank Account statement reflecting therein the salary credited for the period of previous job(s).


The candidates appointed on contract shall be entitled to a consolidated monthly salary of Rs.30,000/-

In case, the number of applicants is large, eligible candidates shall have to undergo a screening test. In order of merit in the Screening test, candidates in the ratio of 1:10 will be called for Objective and descriptive test related to domain knowledge. On the basis of the merit in the test, candidates in the ratio of 1:5 will be called for viva-voce and cumulative merit in the Written test and Viva-voce will determine the final selection.
