- i. The supplier should be a sole proprietary / partnership firm or company and should have been in operation/ existence for more than 5 years. Documents supporting should be furnished with the tender document.
- ii. The sealed quotations shall also contain photocopies of PAN card, Latest ITR for FY 2014-15, 2015-16 & 2016-17, GST certificate, firm registration certificate & Dealer/ Distributor authorization certificate.
- iii. Documents certified by Chartered Accountant or Competent Authority showing that tenderer has an annual turnover of Rs 25 Lakhs each or above for the last three consecutive financial years.
- iv. The supply has to be made within the **10**days from the date of receipt of order from the Institute, failing which a penalty of 0.5% of total amount shall be chargeable.
- v. The rates quoted shall be F.O.R JKEDI, Sempora, Pampore& JLN Udyog Bhawan, Jammu.
- vi. The vendor has to install &configure the Desktop at our both locations as per the requirement of JKEDI.
- vii. The vendor shall have well established local office & backup support.
- viii. The Director, JKEDI reserves its right to increase or decrease the quantity of the items to be supplied.
- ix. The rates quoted should be inclusive of all relevant taxes, octroi, freight, handling charges and/or other duties and levies etc.
- x. The cost offer of the bidder should be written clearly and legibly, both in figures and words.
- xi. The unit rates and prices shall be quoted by the bidder entirely in Indian Rupees and the rates quoted shall be deemed to include price escalation and all taxes. Deduction on account of taxes shall be made from the bills of the contractor on gross amount of bill as per the rates prevailing at the time of release of payment.
- xii. The Institute shall retain 3% of total bill amount for warranty period.
